# The Structure of the Coaching License Training Course in Detail

## **Basic Formation (30 LUs minimum):**

- Offered by the federal Sports Associations.
- Contents: sports organization, legal matters, sports biology, functional gymnastics, mediation techniques, etc.
- A certificate of attendance has to be presented upon granting of the coaching license at the latest.

#### First Aid Course (16 LUs minimum, 2 days of course):

- Offered by the Red Cross and other local charity institutions.
- A certificate of attendance (no older than 2 years) has to be presented upon granting of the coaching license at the latest.
- An examination of the learning contents will take place at the end of the first weekend in written form. The examination is passed if a minimum of <sup>3</sup>/<sub>4</sub> of the questions is answered correctly.

    demonstration of the participant's teaching competences (20 30 min.).

### Getting the License:

The license is granted if...

- ...the participant has passed all of the above exams.
- ...the applicant has proven evidence of his attendance at an interdisciplinary basic seminar as well as of his participation in a first aid course.
- ... the applicant has attained the age of majority.

#### Application:

A written application is required for the participation in each of the training courses offered by the DSBV. Please fill out the application form thoroughly and legibly and send it back to us by mail or by fax, using a distinct form for each training course. Do not forget to enclose a membership confirmation if you are member of a DSBV or ISBO club so that fees can be assigned correctly. If applying for advanced training courses, please include the necessary certificates of qualification. Once we received your application, we will send you a confirmation and further information on the training course. If the number of participants of a course is restricted, applications will be accepted in the order of their arrival. The participation in one of the training courses is not possible if no written application has been received by the DSBV prior to the course and the applicant has not received a confirmation by the DSBV.

#### **Participation Fee:**

Participation fees vary according to whether or not the participant is a member of an ISBO or DSBV club. Please make sure the fee is transferred to the DSBV bank account (Berliner Volksbank, BIN: 100 900 00, account number: 2164863002) two weeks prior to the beginning of the training course at the latest.

#### **Cancellation Policy:**

In order to cancel a training program, a written notice is mandatory.

A cancellation fee of 10% of the participation fee will apply to cancellations made until to the 36<sup>th</sup> day before the beginning of the program. A minimum cancellation fee of 10 Euros will be retained by the DSBV in each case. A cancellation fee of 50% of the participation fee will apply to cancellations made between the 35<sup>th</sup> and the 15<sup>th</sup> day before the beginning of the program and a cancellation fee of 100% will apply to cancellations beyond the 15<sup>th</sup> day before the beginning of the program. In case of absence on the course, 100% of the participation fee will be retained by the DSBV. This policy applies regardless of the submission of a medical certificate. In all cases, the participant has the right to prove that no or only a marginal loss has resulted from his or her cancellation.

#### **Conditions of Participation:**

The host of the training program reserves the right to cancel or rearrange the date of the program on short notice in case of illness, non-achievement of the minimum number of participants or due to other valid reasons. The participation in one of our programs is at your own risk. The liability of the program host is limited to intent and gross negligence, as far as neither the violation of an essential contractual obligation nor death or personal or physical injury are inflicted upon, in which case the host is liable. The same applies to the liability of our assistants. No liability is further assumed for objects that are carried along to the courses by the participants, unless gross or deliberate negligence of the host or one of his or her assistant is responsible for loss or damage. Further, no liability is assumed for any other direct damages that are linked to a course, such as loss of salary, loss of profit, third-party claims, travel expenses, consequential damages and financial losses of every description. The host reserves the right to exclude participants from a course in case of gross violations against the host's interest or gross unsporting behavior or dishonorable behavior. In case of their exclusion, the participants have to be informed by means of a registered letter.

#### Licenses and Certificates:

After having successfully finished a DSBV/ISBO training to become a licensed Speed Badminton coach, a DSBV license ID will be transmitted to the participant, provided that all necessary documents have been presented.
