# 15. New official ICO category – paracrossminton: SSC50 for people with achondroplasia (dwarfism)

New official ICO category – paracrossminton: SSC50 for people with achondroplasia (dwarfism) was presented by Matjaž Šušteršič.

#### 16. Miscellaneous

## 16.1 Implementation of U16 category (proposal by Germany)

"The biological and physical difference of just 14 years old to 18 years old is too big to speak of a fair competition. The other junior categories are also divided at intervals of 2 years."

VOTE Yes votes: 58 No votes: 0 Abstentions: 5

Vote: Yes, the U16 category is confirmed by the ICO General Assembly as an official ICO category.

Vote: No, the U16 category is rejected by the ICO General Assembly as an official ICO category.

The U16 category will become an official ICO category on the 1<sup>st</sup> January 2022 and will also be played at the WC 2021, taking place in June 2022 in Croatia.

## 16.2 Abolishing the 4-categories rule for 2021 retroactively (proposal by Germany)

The proposal was changed in agreement with Germany to directly address the problem of downgrading a tournament due to temporary standards for 2021. A new proposal to upgrade the tournament back to its original ranking points level was then put to vote.

## 16.3 Abolishing the 4-categories rule for 2021 (proposal by Germany)

With immediate effect from today, the rule of at least 4 individual categories in ICO tournaments will be abolished.

# 16.4 Confirming ICO Spanish Open 2021 as a 500 points tournament (proposal by Spain)

Like 16.2, the proposal addresses the problem of downgrading a tournament due to temporary standards for 2021 (while no flight allowed into Gran Canaria) with the aim to upgrade the tournament back to its original ranking points level.

VOTE Yes votes: 63 No votes: 0 Abstentions: 0

Vote: Yes, the ranking points for the ICO Spanish Open 2021 are reinstated back to a 500 points tournament as originally announced.

Vote: No, the ranking points for the ICO Spanish Open 2021 are not reinstated back to a 500 points tournament.

#### 16.5 Defining the tournament season 2022 (proposal by ICO)

After a discussion, the new temporary standards for 2022 crossminton season are proposed as following:

- all national federations (countries) are allowed to organise  $1 \times 500$  points tournament,  $1 \times 500$  points Fun tournament,  $1 \times 500$  points junior tournament,  $4 \times 250$  points tournaments and an unlimited number of 100 points tournaments in 2022. There will be no 1.000 points tournaments in 2022.
- to receive full points for all the tournaments, at least either 2 official ICO single categories or min. 16 players (with obligatory Open and Women categories) must play at the tournament. For all tournaments, participants must come from at least 2 different clubs. Minimum number of players for a category at all these tournaments is 4. If one of the above standards is not reached, the tournament will be downgraded to 100 points (100 points tournament will be downgraded to 0 points).
- doubles-only tournaments are also allowed. Only 250p and 100p doubles-only tournaments can be organised, with at least 3 doubles categories (obligatory OD, WD or MD) and at least 4 pairs per category for these tournaments.
- all tournaments must be officially announced at least 1 month before taking place.
- the organisers are responsible for the organisation of the tournament according to all health protocols and demands in their own country.



- the organisers bear no responsibility for the cancellation of a tournament, even in last-minute, so all players are advised to carefully plan their participation, to communicate with the organiser and to constantly check the entry requirements, if travelling cross-border.
- all health protocols and demands that must be respected at a tournament, must be published by the organiser before the tournament and at the entry point of the tournament venue. All players must respect these protocols and demands, otherwise the organiser can deny their participation at the tournament.

VOTE Yes votes: 50 No votes: 13 Abstentions: 0

Vote: Yes, the agreed tournament standards for the 2022 season are confirmed. Vote: No, the agreed tournament standards for the 2022 season are rejected.

## 16.6 Extension of frozen ranking points into 2022 (proposal by ICO)

The 2021 season is played with the ranking points from the 1st March 2020. All points won through the 2021 season until the 31st December 2021 are added to these existing points. No points will be deleted until the 31st December 2021, when all points from the 1st March 2020 are to be deleted. By doing this, all players would enter the 2022 season only with the points won in the 2021 season. From then on, we would use the same ranking system rules as before the pandemic. Our suggestion is to extend this period of "frozen" ranking points by 6 months, until the 30<sup>th</sup> June 2022, due to the covid situation and tournaments only being played in certain areas of the world in 2021. Also, this would help having more realistic seedings for the WC 2021, taking place at the end of June 2022.

### 16.7 European Championships 2022

The ICO has just received news that the European Championships 2022 will not be able to take place in Russia as planned. The ICO General Assembly agreed to try to find a new host and if the new host is not found in the next weeks, the European Championships 2022 will be cancelled.



## 16.8 Poland - discussion points
