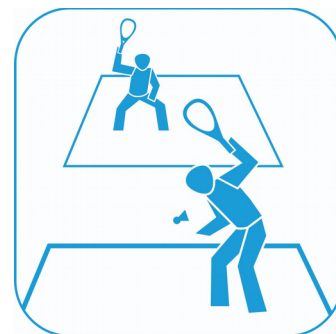

## Standards for ICO 500 points tournaments

**Remember: All players must have a valid ICO licence. Players in ICO member countries have to be registered by the ICO member.**

**Sponsoring support for ICO tournaments will be calculated on the following allocate formula:**

**100 % SPONSORSHIP → 90%-100% POINTS ACHIEVED**

**80 % SPONSORSHIP → 80%-90% POINTS ACHIEVED**

**60 % SPONSORSHIP → 70%-80% POINTS ACHIEVED**

**40 % SPONSORSHIP → 60%-70% POINTS ACHIEVED**

**20 % SPONSORSHIP → 50%-60% POINTS ACHIEVED**

**0 % SPONSORSHIP → 0%-49% POINTS ACHIEVED**

**There is at least 1 independent observer on each tournament.**

**Tournament standards are supervised by the ICO Board members, who make a final report about achieved %.**

## Must be done before the tournament

TO DO	Description	Deadline	RATE
Tournament Application	The tournament date must be submitted to the ICO by the 30th October of the previous year (for tournaments in the first half of the year) or the 28th February of the current year (for tournaments in the second half of the year). ICO Board will make the final decision about the tournament calendar 14 days later in order for the tournaments not to overlap. The tournament must then (see the deadline!) be officially announced in Tournament Software at <a href="http://ico.tournamentsoftware.com">ico.tournamentsoftware.com</a> by the National administrator.	30.11. of the previous year or 30.03. of the current year	Obligatory! If missed, no ICO support.
Tournament Announcement	All relevant information about the tournament must be published in Tournament Software for all players to see.  All official ICO singles and doubles (KO-system possible for doubles, but not singles) categories must be announced.  Registration deadline for the participating players must be at least 14 days before the start of the tournament.	3 months before	Obligatory! If missed, no ICO support.
Organisation staff (recommended not to play)	1 full time organizer (recommended not to play). Fill out the name of the full time organizer under „Organizer Contact Info“ in tournament application (Tournament Software).	3 months before	2,50%, if the organizer does not play
Head Umpire (recommended not to play).	1 licensed Head Umpire (recommended not to play). - Fill out the name of the licensed Head Umpire under „Referee Info“ in tournament application (Tournament Software).	3 months before	2,50%, if the licensed Head Umpire does not play
Seedlist & draw	<ul style="list-style-type: none"> <li>Results will only be valid for the ICO ranking if at least 4 registered players participate (4 pairs for doubles) in a category and at least 2 singles categories are played at the tournament. If a category is cut due to a lack of participants, the registered participants of that category will be placed in the next higher category. Exception: U12 and U14 male and female participants must be mixed into one category as well as U18 doubles. If participants have to play a higher category, they will be seeded after their ranking in the higher category. If they do not have a ranking, they will be drawn by lot. Players that cant play their own category due to the low number of players will play any other</li> </ul>	<b>Send the .tp file with the draw to B. Jerković at least 5 days before the tournament for inspection!</b>	10,00%

Send the draw after the no-return deadline as a .tp file to the ICO (<a href="mailto:jerkovic@crossminton.org">jerkovic@crossminton.org</a>, without request of the ICO!) before publishing.</li> </ul> <p><i>Your whole tournament must be done in accordance with the ICO Tournament Regulations, the ICO Rules of Crossminton, the ICO Umpire Regulations and all other relevant ICO documents.</i></p>

Courts	at least 4	Obligatory! If missed, no ICO support.	
Min. categories/competitors	At least 4 official ICO categories OR at least 30 players	Registry deadline	12,50%
Min. capacity of players	30; If number of participants in 500 points tournaments is limited, the participation will be decided after the ranking position and official deadlines of the tournament!	-	5,00%
Draw/ time table	<p>Matches must be played according to the time table.</p> <p>Players who register for an ICO tournament but do not show up without any written and approved reason receive minus 100 points for the ranking in each division they have registered (please send the ICO the names of these players via the tournament report!).</p>	-	5,00%  (subjective decision by the observer)
Umpire Responsibilities	<p>Match- &amp; line umpire from semi final.</p> <p>Assignment of one licensed head umpire.</p> <p>Use the official (and last version) of the ICO score sheets.</p>	-	5,00%

Moderation	One full-time moderator. Moderator must announce ICO sponsors during the tournament.	-	2,00%
Award ceremony	Ceremony with podium, main sponsor of the tournament & ICO advertising, national anthem of the winners and speaker.  Certificates (with signature of tournament official) and medals/trophies for the 1.- 3. places of the category.  Cash prize for the winner of the female and open singles category.	-	10,00 %  6,00 %  6,00 %
Further Standards	<ul style="list-style-type: none"> <li>• LIVE-Stream, incl. ICO partner adds;</li> <li>• 2 days tournaments must compulsory end at the latest by 2 p.m. (on Sunday);</li> <li>• Sponsoring requirements for ICO partners: advertising at facility (incl. final court branding for the live stream); Announcement from the moderator at the venue; Integration in official ICO press releases. Tip: Use the official sponsoring package from the ICO (ask the ICO at least 30 days in advance of the event);</li> <li>• Medical care must be provided by the organiser &amp; sanitary facilities are necessary;</li> <li>• During tournament, information about time and courts of the next matches must be published at the venue;</li> <li>• Build up a special bannered (all ICO sponsors!) and designed center court;</li> <li>• Scoreboards are required (one per Court);</li> <li>• Players party;</li> <li>• Marking &amp; size of the match courts according to the ICO standards (court numbers, serve line, ... );</li> <li>• Appoint an official photographer and publish a photo gallery in social media (at least 50 photos + all medal ceremonies) after the tournament</li> </ul>	-	3,50%  5,00%  7,50%  Obligatory!  2,50%  2,50%  2,50%  recommended  2,50%  2,50%

Player's fee (2,50 € per player)	Players must have a valid ICO licence. The Player's Fee total (2,50€ for each player goes to the ICO) is calculated after the tournament by the ICO and is deducted from the sum of ICO sponsoring.	1 month after the tournament	
Results & Tournament report	Send the official ICO Tournament Report to <a href="mailto:jerkovic@crossminton.org">jerkovic@crossminton.org</a> and <a href="mailto:sustersic@crossminton.org">sustersic@crossminton.org</a> , including some HQ photos to be published in ICO media.	One day after the tournament: next day till 12 p.m. Two or more days TM: On the same day after the tournament.	Obligatory! If missed no ICO support.
